CALL FOR ABSTRACTS

The 16th Annual Injury Biomechanics Symposium will stimulate and reward strong injury biomechanics research among students and recent graduates. The Symposium Committee invites abstracts of prospective presentations in all areas of traumatic injury biomechanics. Studies of interest include those that quantify human injury tolerance, develop analytical or experimental tools that assess injury risk, or evaluate the effectiveness of safety countermeasures in environments such as automotive crashes, sports injuries or military trauma. All selected podium presenters will prepare a written manuscript to be included in the symposium proceedings. Stipends will be awarded to selected presenters, both oral and poster, to assist with travel expenses.

3. An abstract of no more than 500 words containing:
 - Clear statement of the study objective(s)
 - Outline of the problem that the study attempts to solve
 - Methodology
 - Data to be included
 - Summary of results and current conclusions
4. State whether you would prefer a poster or an oral presentation slot. The committee reserves the right to alter the presentation type based on the submitted abstracts.
